Official Photo Contest Rules

We will accept images created with any digital device including smartphones, and digital still cameras (including medium and large-format cameras). Images that have been re-touched using software or by other means will not be accepted.

We will not be accepting any images taken on film. Scans of photographs taken on film cameras are not eligible.

File Sizes: up to 25MB per image.

File Format: REG / 300dpi recommended

Contestants under 18 years of age require the permission of a parent or legal guardian. Winners are responsible for all applicable taxes pertaining to grand prize winnings.

All submitted images become the property of Orbit Industries, Inc. Please see Terms and Conditions for more details.

Please, no blurry or pixelated (compressed) digital images. Such images will not be eligible to receive an Orbit Hat and Catalog
